



Infant Adoption Program Fees

We (I) \_\_\_\_\_ and \_\_\_\_\_ hereby agree to pay the applicable program fees for the following:

- I. Adoptive home study, licensure, references, background checks \$2,500  
 This portion paid to initiate the process: \$1,250  
 This portion paid at completion, prior to release of the adoptive home study: \$1,250
- II. Adoptive home study update (for subsequent adoptions) \$2,000  
 This portion is paid to initiate the process: \$1,000  
 This portion is paid at completion, prior to release of the adoptive home study: \$1,000
- III. Home study update fee \$250  
 This fee is paid upon completion, prior to release of the update.
- IV. Placement of an infant when FamilyCore assumes guardianship.  
*Fee based on average of adjusted gross income from last two tax returns. (See chart below)*
- V. Post placement report(s) \$250  
 This/These fee(s) is/are paid upon completion of the report(s).
- VI. Report of Investigation for adoption finalization \$250  
 This fee is paid upon completion of the report.
- VII. Website fee for online profile posting \$85.00  
 This fee is paid at time of submission of documents and prior to Agency posting the profile
- VIII. Travel fees  
 \*Fees applicable to clients residing outside the normal service area. Two hours of travel time and mileage up to 100 miles, round-trip from the FamilyCore office, will be at no cost to the client. Beyond these ranges, the following fees apply:
  - A. Travel time \$42.50/hour
  - B. Mileage \$.445/mile

The agency agrees to offer and/or provide counseling to the birth couple, secure termination of parental rights, assume guardianship of the child, and provide appearance and consent forms to the court at the finalization of the adoption. The adoptive family assumes medical expenses for the child and birth mother, foster care, and living expenses of the birth parents, if necessary, which is in addition to the placement fee. Every effort is made to secure public assistance and/or insurance coverage for medical costs. Fees are payable at time of placement.
